- c) Generators are not working for #5 or for #1. We are waiting for a price on a new generator. This should come in the next few days. We need a permit from TCEQ for a backup generator for #5.
- d) Jerel talked about his pay (\$500 per month) and he takes about 15 hours to read all the meters; wear and tear on his truck. He's asking for a raise of \$1 per meter, and this will change each month. A counter offer is to give him a \$1 per meter and change the pay each 6 months based on the number of meters that have been added in the previous 6 months.
